### SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Organic #2. Store with alcohols, glycols, amines and amides. Keep refrigerated (2-8°C). Light sensitive, may change color if exposed to light. Keep container tightly closed (P233). Use only in a well-ventilated area or in a hood (P271).
